Scope

This part of ISO 8489 specifies the main dimensions colerances and designation of cones for cross winding for dyeing purposes with a half angle of cone 4° 20'. Furthermore, directives are given for the characteristics of cones and for the control of the diameters and lengths of the cone.

NOTES

- 1) The width of wound yarn shall not exceed l-25 mm.
- 2) The deviations from the nominal value 4° 20' of the half angle of the cone are limited by the tolerances for d, d_1 and I, as indicated in the table. They do not influence the practical use of the cones during dyeing and further processes.
- *) Main dimensions as recommended in ISO 8489-1.

4 Characteristics


The following details shall be specified by the manufacturer:

- a) cone material [suitable metal or plastic or an impregnated or lacquered paper (resistant to boiling)],
- b) surface treatment;
- c) nature of yarn to be wound;
- d) thickness of cone wall (corresponding to the nature of the yarn to be wound);
- e) number, size and location of perforations.

The minimum distance between the ends of the cone and edges of the nearest holes shall be $16 \text{ mm} \pm 0.5 \text{ mm}$.

5 Dimensions, tolerances and use of the gauges

See figure 2 and table 2.



The inner dimensions of the cone are in accordance with this part of ISO 8489 if the edge of the larger end of the cone, after it has been placed gently on the gauge and then pressed firmly home by hand, is between the tolerance marks.

To check the smaller diameter of an open-ended cone, it shall be placed firstly with the smaller end on the gauge. The edge of the smaller end of the cone must then lie between the tolerance marks on the corresponding end of the gauge.

Control of cone length

To check the tolerances of the length of the cone, a suitable gauge for checking lengths, for example, a slidegauge, must be used. The conical gauges shown cannot be used for this purpose.

Designation 7

The designation of a cone for cross winding with a half angle of 4° 20' for dyeing purposes shall include the following information, in the order given:

- "Cone";
- b) reference to this part of ISO 8489, i.e. ISO 8489-4;
- its large inner diameter, d, in millimetres;
- d) its length, l, in millimetres.

EXAMPLE

508A89.A.1995 or diam. Click to view the full PDF. A cone with a half angle of 4° 20' for dyeing purposes with a large inner diameter d of 59 mm and length l of 170 mm shall be designated as follows:
